On December 27, 2011, our office received from the Grant County Water Conservancy Board a Record of Decision and Report of Examination for the above referenced application for change/transfer of a water right certificate. In accordance with RCW 90.80.080 the Department of Ecology (Ecology) has reviewed the Record of Decision and Report of Examination and has considered all comments, protest, objections, and other relevant information submitted to Ecology regarding the proposed change/transfer.

Ecology has affirmed the decision of the Board and the proposed change/transfer of water right is approved.

RCW 90.03.386 may have the effect of revising the place of use of this water right if criteria in section RCW 90.03.386(2) are met.

To appeal, you must do the following within 30 days of the date of receipt of this decision:


- File your appeal and a copy of this decision with the PCHB (see addresses below). Filing means actual receipt by the PCHB during regular business hours.
