On November 2, 2012 our office received from the Walla Walla County Water Conservancy Board the Record of Decision for the above referenced application for change/transfer. In accordance with RCW 90.80.080 the Department of Ecology has reviewed the Record of Decision and Report of Examination and has considered all comments, protests, objections, and other relevant information.

The Department has **affirmed** the decision of the Board and the proposed change/transfer of water right is **approved**.
