The provisions under the above noted certificate allows for the utilization of 2 wells, pumping 1600 GPMs, 1755 Acre-Feet, for the irrigation of 628.5 acres as a supplemental supply to Ground Water Certificate No. 1476. Under the proposed change the number of wells would increase to 4 wells, with no change in the instantaneous flow, of 1600 GPM's, or the annual withdrawal of 1755 Acre-Feet, less any amount withdrawn under Groundwater Certificate No. 1476.
