The dairy operated within the certificate area of use, parcel # 161483000 until about 1970 at which time to meet the State Department of Health requirements the dairy facilities were replaced; at that time new dairy facilities were constructed on parcel # 170754000 to allow ongoing operation of the dairy during construction of the new facilities; a water line was installed to supply water from well 1A and from well 2A for backup supply for the dairy. The dairy continued to operate until 2006.

In 2010 the dairy portion of the water right was temporarily donated to the state ground water trust program. This application is to change location of use, purpose of use from Dairy Water to domestic use and the point of withdrawal. After approval of the change the intent of the owner is to keep this portion of the water right temporarily donated to the state ground water trust program.
