27.67 acres within portions of the SE $\frac{1}{4}$ SE $\frac{1}{4}$ Sec. 22, the NE $\frac{1}{4}$ NE $\frac{1}{4}$ and the SE $\frac{1}{4}$ NE $\frac{1}{4}$ and the NW $\frac{1}{4}$ NE $\frac{1}{4}$ of Sec. 27, all within Township 7 N., Range 35 E.W.M., more specifically described as Blalock Orchards Parcel A, as shown and recorded on SP 4-41, SP 4-53, Book 10 Page 144, June 5, 2007, County of Walla Walla, State of Washington

PROVISIONS

All conditions and requirements contained in reports of examination or permits previously issued apply to this superseding certificate unless specifically noted below.

This superseding certificate is the result of an administrative division of Walla Walla River Adjudicated Certificate No. 590(B) into Adj. Cert. Nos. 590(B) - Brunchgrass LLC, and 590(D) - Cockerline. The third party owner of the original 590(B), Scholl/Lasher claimed zero interest in the right. This administrative division shall not be construed as validation as to the extent of Adj. Cert. No. 590(B) as originally authorized. The quantities provided on the superseding portions of this water right reflect agreement among the owners of the described place of use, but are not confirmed by Ecology in the recording of the division of said right. The actual amounts authorized by the superseding certificates are subject to historic beneficial use of WW River Adj. Cert. No. 590(B).

When the supply of water for irrigation purposes from April 1 to October 1 is insufficient in the Walla Walla River Valley to fill any adjudicated surface right, the owner of such a right is entitled to divert water during the period of October 1 to April 1.

Water available under this authorization may not provide a continual supply throughout each irrigation season.

The amount of water granted is a maximum limit that shall not be exceeded and the water user shall be entitled only to that amount of water within the specified limit that is beneficially used and required for the actual crop(s) grown on the number of acres and the place of use specified.

This authorization to make use of public waters of the State is subject to existing rights, including any existing rights held by the United States for the benefit of Indians under treaty or otherwise.

Nothing in this authorization shall be construed as satisfying other applicable federal, state, or local statutes, ordinances, or regulations.


Any person taking water from the Walla Walla River or its tributaries under this right shall provide and maintain, at his/her own expense, proper diversion works and measuring devices as required by statute under RCW 90.03.360.

The right to use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described, except as provided in RCW 90.03.380, 90.03.390, and 90.44.100.

This superseding certificate of water right is specifically subject to relinquishment for non-use of water as provided in Chapter 90.14 RCW.
