All conditions and requirements contained in reports of examination or permits previously issued apply to this superseding certificate unless specifically noted below.



This administrative division shall not be construed as validation as to the extent of Ground Water Certificate No. 398-D as originally authorized. The quantities provided on the superseding portions of this water right reflect agreement among the owners of the described place of use, but are not confirmed by Ecology in the recording of the division of said right. The actual amounts authorized by the superseding certificates are subject to historic beneficial use of Ground Water Certificate No. 398-D.

Water available under this authorization may not provide a continual supply throughout each irrigation season.


