

NOTE: This application to enter a water right into the trust water right program is used only when a water right is proposed to be entered into the state trust water right program through an acquisition by lease, purchase, or donation and there are no other modifications to the water right being proposed. If other modifications to water right that will remain with the water right holder are proposed, an Application to Change/Transfer a Water Right, Ecology form number 040-1-97 must be filed instead of this form.

NOTE: No fee is required with this application if the proposal results in a donation of a water right to the trust water right program or if the state acquires a trust water right for instream flows or other public purposes.

INSTRUCTIONS

1. **Applicant Information:** Identify the name and contact information for the applicant that is filing the proposal to enter a water right into trust. Provide contact information for the application if it differs from the applicant.
2. **Water Right Information:** Complete the following:
 - Provide the water right document number (i.e., certificate, claim, etc.) and the names of the individuals as identified upon the water right document;
 - Check the appropriate boxes indicating:
 - Whether you are the owner of the water right proposed to become a trust water right. If you are not the owner, identify the owner and the owner's contact information;
 - Whether the water right has been exercised during the past five-years;
 - Whether the water use is measured, and;
 - Provide any information, such as records of measurement, pump electrical consumption records or other information that indicates specifically the extent of water use during the past five-years and general information of the extent of historic water use.
3. **How is Water to be Made Available for Trust?** Indicate what alteration to the existing water use under the water right is planned to make water right available for the trust water right program. Check all boxes that may apply.
4. **Point(s) of Diversion/Withdrawal:** Describe the diversion or withdrawal at the point at which water is taken from a public water body, such as a stream or from a well. If water is taken from a well, attach all existing records of the well.
5. **Purpose of Use: Part A:** Identify the current purposes of water use (i.e., irrigation, stockwater, domestic, etc.) and the season of use (i.e., continuous, year-round, April – September, etc.), as well as the existing quantities of water use as authorized under the water right. **Part B:** Identify any proposed purpose of use and the water quantity intended for use of the water right while in the trust water right program.
6. **Place of Use: Part A:** Describe the legal description (i.e., $\frac{1}{4}$ $\frac{1}{4}$, Section, Township, Range, etc.) of the lands where the water right is currently used. Also, identify whether the applicant is the owner of all the existing place of use. If the applicant is not the owner, provide the name(s) of the property owner(s). **Part B:** Identify the water body or other place that is expected to benefit while the water right is in trust.
7. **Remarks and Other Relevant Information:** Provide any information that further explains the trust water right proposal.
8. **Signatures:** The application must be signed by the applicant, the water right holder, and the land owner of the existing place of water use, if different from the water right holder. Additionally, if the water right is within an irrigation district, the application must be signed by a representative with signature authority for the irrigation district.

Attachment: An attachment is available for continuing the information required within Items 4, 5, and 6.
