

The provisions under the above noted certificate allows for the utilization of 1 well, pumping 600 GPMs, 240 Acre-Feet, for the irrigation of 60 acres. Under the proposed change the number of wells would increase to 8 wells, with no change in the instantaneous flow, with a reduction in the total annual withdrawal down to 171.65 Acre-Feet, and an increase in total acreage to 68.66 Acres.
