The provisions under the above noted certificate allows for the utilization of 5 wells, pumping 200 GPMs, 80 Acre-Feet, for the irrigation of 20 acres. Under the proposed change the number of wells would increase to 8 wells, with no change in the instantaneous flow, with a reduction in the total annual withdrawal down to 49.66 Acre-Feet, and a decrease in total acreage to 13.16 Acres.
