6. Remarks and Other Relevant Information:

The provisions under the above noted permit allows for the utilization of 3 points of withdrawal, pumping 12 CFS, with an annual withdrawal of 4240 Acre-Feet, for the seasonal irrigation of 1060 acres. Under the proposed change the number of points of withdrawal would increase to 4, with no change in the instantaneous flow, with no reduction in the total annual withdrawal, there will be an additional place of use added to the permit along with a change in acreage to 1054 acres reflecting the existing irrigated acreage along with the additional acreage associated with spreading.
