On December 3, 2012 we received four applications for change to add a well to the above described rights. The applications were accepted and given the following numbers:

On October 28, 2013, four new applications for change were filed on the above described water rights with the Grant County Conservancy Board. These applications requested to add a well and change the place of use of the described rights. As we discussed, these applications filed on October 28, 2013 will be pursued and the applications filed with Ecology will be rejected. These conservancy board applications supersede the applications filed with Ecology.

Therefore, the four applications for change identified above filed with Ecology on December 3, 2012 are **REJECTED**.

Your Right To Appeal

You have a right to appeal this decision to the Pollution Control Hearings Board (PCHB) within 30 days of the date of receipt of this decision. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal you must do the following within 30 days of the date of receipt of the decision.




File your appeal and a copy of this decision with the PCHB (see addresses below). Filing means actual receipt by the PCHB during regular business hours.

- Serve a copy of your appeal and this decision on Ecology in paper form - by mail or in person. (See addresses below.) E-mail is not accepted.
- You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.



Review Legal Notice Carefully

It is your responsibility to check the notices carefully before having them published. If you find an error, please contact this office for resolution. If we later find an error in your public notices, you may be required to publish an amended notice at your expense.

Publishing Legal Notice

You need to arrange and pay for publishing the legal notices in a newspaper in Grant County.

- Publish in one of the following newspapers:
 - Coulee City News-Standard; or
 - Columbia Basin Herald; or
 - Grant County Journal; or
 - Quincy Valley Post-Register; or
 - The South County Sun; or
 - The Star Newspaper
- These newspapers have general circulation in the area the water will be used and diverted.
- Ensure that the notices appear once a week for two consecutive weeks.

If your published notices do not meet the above criteria, you will be required to have the notices republished at your expense.



Publication should start within 30 days from the date of this letter.

Next Step

You must request an *Affidavit of Publication* from the newspaper in which your notice appeared. The affidavit must be an original, notarized copy of your published notice. Please forward it to our office as soon as possible.


