


LEGAL DESCRIPTION

That portion of Government Lot 4, Section 32, Township 13 North, Range 9 East, W.M., Lewis County, Washington, lying southerly of the easterly fork of the Cowlitz River. EXCEPT the south half of the southeast quarter of the northeast quarter of said Section 32. ALSO EXCEPT the Johnson Creek County Road, formerly State Road No. 5, as conveyed to the State of Washington by deed recorded June 25, 1925 under Auditor's File No. 177895.

ALSO that portion of Government Lot 5, Section 32, Township 13 North, Range 9 East, W.M., Lewis County, Washington, lying northwesterly of U.S. Hwy No. 12. EXCEPT the Johnson Creek County Road, formerly State Road No. 5, as conveyed to the State of Washington by deed recorded June 25, 1925 under Auditor's File No. 177895.

EXCEPTING THEREFROM that portion of said Government Lots 4 and 5, Section 32, Township 13 North, Range 9 East, W.M., Lewis County, Washington, described as follows:

Beginning at the intersection of the centerline of Johnson Creek with the easterly line of said Government Lot 5; thence northerly along said easterly line and the northerly production thereof, to the southerly right-of-way line of that 60 foot wide strip of land conveyed to the State of Washington for State Road No. 5 (Johnson Creek County Road) by that deed recorded June 25, 1925, in Volume 181 of Deeds, page 11, under Auditor's File No. 177895; thence westerly, along said right-of-way line, to the center line of said Johnson Creek; thence southeasterly, along said center line, to the Point of Beginning.

ALSO that portion of the south half of the northeast quarter of the southeast quarter of Section 32, Township 13 North, Range 9 East, W.M., Lewis County, Washington, lying northwesterly of the northerly right-of-way line of U.S. Hwy. No. 12 as described in deed to the State of Washington recorded August 4, 1960 under Auditor's File No. 615478.

ALSO that portion of the southwest quarter of the southeast quarter of Section 32, Township 13 North, Range 9 East, W.M., Lewis County, Washington, lying northwesterly of said U.S. Hwy. No. 12.

ALSO that portion of the south half of the northwest quarter of Section 33, Township 13 North, Range 9 East, W.M., Lewis County, Washington, lying northwesterly of the northerly right-of-way line of U.S. Hwy. No. 12 as described in deed to the State of Washington recorded August 4, 1960 under Auditor's File No. 615478 and southerly and easterly of the easterly fork of the Cowlitz River. EXCEPT the Johnson Creek County Road, formerly State Road No. 5 as conveyed to the State of Washington recorded June 25, 1925 under Auditor's File No. 177895.

ALSO EXCEPT that portion of the southeast quarter of the northwest quarter of said Section 33, described as follows:

Beginning at the northwest corner of said southeast quarter of the northwest quarter; thence east 258.98 feet along the north line of said southeast quarter of the northwest quarter to the northwesterly right-of-way line of U.S. Hwy. No. 12 (formerly Randle-Yakima Hwy.) thence southerly 250.35 feet, more or less, along said northwesterly right-of-way line; thence west 108.34 feet to the west line of said southeast quarter of the northwest quarter; thence north along said west line to the Point of Beginning.

ALSO EXCEPT the west 60 feet of that portion of the southwest quarter of the northwest quarter of said Section 33, lying south of the Johnson Creek County Road (formerly State Hwy. No. 5).

LEGAL DESCRIPTION

That portion of Government Lot 4, Section 32, Township 13 North, Range 9 East, W.M., Lewis County, Washington, lying southerly of the easterly fork of the Cowlitz River. EXCEPT the south half of the southeast quarter of the northeast quarter of said Section 32. ALSO EXCEPT the Johnson Creek County Road, formerly State Road No. 5, as conveyed to the State of Washington by deed recorded June 25, 1925 under Auditor's File No. 177895.

ALSO that portion of Government Lot 5, Section 32, Township 13 North, Range 9 East, W.M., Lewis County, Washington, lying northwesterly of U.S. Hwy No. 12. EXCEPT the Johnson Creek County Road, formerly State Road No. 5, as conveyed to the State of Washington by deed recorded June 25, 1925 under Auditor's File No. 177895.
