

As referenced in your letter of July 11, 1996, you will find enclosed two applications for change, as referenced above, along with statutory examination fees of \$10.00 for each of the applications.

For consistency of records, note that the City is also requesting the place of use under Certificate 562-D to be the "Area served by the City of Centralia."

Additionally, Ground Water application No. G2-28782A should be amended to include a 2nd well (Tennis Court). It is the City's understanding that this will likely require republication. If so, please send us an amended notice for publication.

Finally, as you are aware, the City needs to start construction of the Tennis Court Production Well almost immediately. Therefore, we are requesting a temporary authorization to begin construction as soon as possible, with the full understanding that the authorization shall in no manner be construed to prejudge Ecology's final decisions on the application.

G2-28214 - Washington St. Well - add 1,1886 AF/Y
 G2-28215 - K St. Well - add 1,214 AF/Y
 G2-28782 - North Tower St. Well - add 943 AF/Y

Gale, here are my notes on the above applications:

- See map attached.
- See my R. O. E.'s for G2-28212 and Change 4491 (to Jill for review, etc., today)
- All 3 wells have Declared Certificates for the correct gpm's, but small annual quantities reflecting only 60 days' use each year. The app's request additional AF/Y for year-round use.
- Possible reasons to defer action on these:
 - Washington St. and K. St. wells have been in use most of each year since at least 1990. We issued a temporary permit to allow this in 1991; it has been extended to 11/1/94. As far as I know, the Dept. of Health does not have a problem with continuing that arrangement. Check with Mike Olden.
 - North Tower St. Well has been off line since at least 1989 due to detection of VOC's (below mcl, but worrisome). They may want to change POW or install treatment eventually.
- Proximity to Skookumchuck River suggests potential impact on flows; Skookumchuck is closed July 1 - Sept. 30 each year. If we issue these, limit new quantities to Oct. 1 - June 30?

Another possibility: they do not use the Downing Rd. Well (see NE corner of map) nearly as much as it has rights for under G2-24010C (1,300 gpm, 2,000 AF/Y total prim. + suppl.) * Perhaps some of those quantities could be changed to the 3 wells in question; or relinquished as mitigation?

- There would also be potential impact on Chehalis River flows

* Centralia Comp. Plan p. III-5 (muri. book shelf)

from these increases. Condition like G2-28212 (Eshom/Borst Park Wells), granting these quantities only as an alternative to the City's North Fork Newaukum River diversion (presumed vested right for 6.9 cfs, not presently in use).

- Whatever increased AF/Y we give them will be supplemental to their other GW rights -- see G2-28212 R. O. E.




