Dear Ms. De Boer:

In response to your request, you are hereby granted an extension to file a Proof of Appropriation on the above-referenced water right for the reasons below:

- Permit holder has experienced financial complications and is unable to make necessary repairs on the system at this time.
- Permit holder's property is currently for sale but has yet to receive any offers.

Please note that if more time is needed to complete the project beyond this extension, Ecology will consider whether completion of this project is feasible and it is likely that additional time may not be granted.

The new deadline to put the water to **full beneficial use** and send a completed Proof of Appropriation form is **May 1, 2015**.

YOUR RIGHT TO APPEAL

You have a right to appeal this decision to the Pollution Control Hearing Board (PCHB) within 30 days of the date of receipt of this letter. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal you must do the following within 30 days of the date of receipt of this decision:

- File your appeal and a copy of this letter with the PCHB (see addresses below). Filing means actual receipt by the PCHB during regular business hours.
- Serve a copy of your appeal and this letter on Ecology in paper form - by mail or in person. (See addresses below.) E-mail is not accepted.

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.




