**Re: APPROVED Seasonal Change Authorization for Surface Water
Certificate (SWC) 5183, Whatcom County, Water Resources Inventory
Area 1**

The Department of Ecology (Ecology) received your application for a seasonal change of Surface Water Certificate (SWC) 5183 on March 30, 2016. Your application has been assigned control number CS1-*11131C@3. Please refer to this number when corresponding with us about this seasonal change request.

BACKGROUND INFORMATION

The above-referenced certificate authorizes the diversion of 0.24 cubic feet per second (cfs) from Kamm Ditch for the irrigation of 24 acres. This certificate was issued to Norman Beukelman with a priority date of March 10, 1952. The authorized place of use is Whatcom County parcel number 400320495365, located within the E½ E½ of Section 20, Township 40 North, Range 3 East. The authorized point of diversion is within the NE¼ SE¼ of Section 20, Township 40 North, Range 3 East.

SWC 5183 is currently owned by Howard Top of Lynden, Washington. Mr. Top historically has pumped up to 0.24 cfs from Kamm Ditch to sprinkler irrigate 24 acres of grass within his 34-acre farm property. With Mr. Top's agreement, you are requesting to add Whatcom County Parcel number 400320540230 to the existing place of use of SWC 5183 for the upcoming 2016 irrigation season. You are not requesting to increase the authorized number of irrigated acres. The total allowable number of irrigated acres will remain at 24. Mr. Top has agreed to reduce his number of irrigated acres this upcoming season in order to free up water for your use.

In addition, much of Mr. Top's property has been entered into the Conservation Reserve Enhancement Program (CREP), thus reducing his need for irrigation water this season. The entire length of Kamm Ditch within Mr. Top's property is now a riparian buffer zone of native vegetation planted to help protect water quality, stabilize the stream bank, reduce erosion, and create shade to lower water temperature.

You, with Mr. Top's agreement, have also requested to seasonally add a point of withdrawal within the NE¼ SE¼ of Section 20, Township 40 North, Range 3 East. This



additional point of withdrawal is shallow, is in close proximity to the existing point of diversion, is within the same legal description as the original point of diversion, and is within the same subbasin (Kamm Ditch watershed) as the original point of diversion. Therefore, it is within the same source of supply.

There are no intervening rights between the original point of diversion and the proposed additional point of withdrawal, so there will be no impairment of existing water users.

DEPARTMENT OF ECOLOGY DECISION - INCLUDING TERMS & CONDITIONS

Your request for a seasonal change in the place of use and for an additional point of withdrawal for the 2016 irrigation season is hereby **APPROVED** under the terms and conditions listed below.

- You and Mr. Top are authorized to irrigate no more than 24 acres total within parcels 400320495365 and 400320540230, all within the E $\frac{1}{2}$ E $\frac{1}{2}$ of Section 20, Township 40 North, Range 3 East.
- This seasonal change does not authorize an enlargement of water use or total irrigated acres as described in SWC 5183. Irrigation of any lands removed from irrigation within the original place of use will constitute an enlargement of the right and will result in immediate cancellation of this authorization.
- The original point of diversion from Kamm Ditch and the additional point of withdrawal shall be located within the NE $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 20, Township 40 North, Range 3 East.
- The authorized instantaneous rate cannot be exceeded at any time. The total rate of pumping from all points shall not exceed 0.24 cfs (108 gallons per minute). You are required to coordinate with Mr. Top to ensure compliance with this condition.
- An approved measuring device shall be installed and maintained on the authorized point of diversion and the additional point of withdrawal in accordance with the rule "Requirements for Measuring and Reporting Water Use", WAC 173-173. In order to ensure compliance with the terms of this authorization, water use data shall be recorded weekly and shall be promptly submitted to Ecology upon request.
- WAC 173-173 describes the requirements for data accuracy, device installation and operation, and information reporting. It also allows a water user to petition Ecology for modifications to some of the requirements. Installation, operation and maintenance requirements are enclosed as a document titled "Water Measurement Device Installation and Operation Requirements". - This seasonal change is subject to existing rights, including any rights held by the United States for the benefit of tribes under treaty or settlement. By ensuring no enlargement of the rate of water use or the number of irrigated acres, this seasonal change authorization should have no greater impact on tribal rights than the original authorization.
- If it can be shown that water use authorized by this seasonal change is causing impairment of existing rights or is being used illegally, then this authorization will be immediately canceled.
- This seasonal change does not convey a right of access to, or other right to use land, which you do not legally possess. Obtainment of such a right is a private matter between you and the owner of the land.
- This seasonal change shall be in effect through October 1, 2016 (unless canceled sooner); at which time the subject right will revert back to the original attributes described in SWC 5183.
- Violation of any of the terms and conditions of this seasonal change will result in this authorization being immediately canceled, issuance of administrative orders to cease and desist, and may also subject the violator to civil penalties.
- The Department of Ecology may field verify this seasonal change at any time for compliance with the terms and conditions of this authorization.
- All conditions and provisions in the original water right must be complied with.
- **THIS AUTHORIZATION SHALL IN NO MANNER BE CONSTRUED TO GUARANTEE OR IMPLY THAT A FINAL (REGULAR) CHANGE AUTHORIZATION WILL ISSUE FOR THE FUTURE USE OF THE WATER HEREIN AUTHORIZED.**

OPPORTUNITY TO APPEAL

You have a right to appeal this action to the Pollution Control Hearing Board (PCHB) within 30 days of the date of receipt of this document. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal, you must do the following within 30 days of the date of receipt of this document:

- File your appeal and a copy of this document with the PCHB (see addresses below). Filing means actual receipt by the PCHB during regular business hours.
- Serve a copy of your appeal and this document on Ecology in paper form - by mail or in person. (See addresses below.) Email is not accepted.

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.
