Dear Mr. Latta:

In response to your request, you are hereby granted an extension to put the water to full beneficial use for the reason(s) below:

According to your request, the flow meter for your project did not function properly and has left you with unusable data. This meter was replaced in March of 2009. You have requested to have additional time to collect water use data. It appears you have made substantial goals in putting your project to complete beneficial use. Your request is for a reasonable and short period of time.

The new deadline to submit your *Proof of Appropriation of Water* is July 1, 2010.

You have a right to appeal this decision. To appeal this you must:

- File your appeal with the Pollution Control Hearings Board within 30 days of the “date of receipt” of this document. Filing means actual receipt by the Board during regular office hours.
- Serve your appeal on the Department of Ecology within 30 days of the “date of receipt” of this document. Service may be accomplished by any of the procedures identified in WAC 371-08-305(10). “Date of receipt” is defined at RCW 43.21B.001(2).

Be sure to do the following:

- Include a copy of this document that you are appealing with your *Notice of Appeal*.
- Serve and file your appeal in paper form; electronic copies are not accepted.
