Dear Mr. and Mrs. Beaber:

In response to your request, you are hereby granted an extension to put the water to full beneficial use for the reason below:

- Additional construction is in process. More time is needed to put water to full beneficial use.
- Additional time is needed to install a meter and record diversions.

The new deadline to submit *Proof of Appropriation of Water* is **November 1, 2012**. The *Proof of Appropriation* form must be accompanied by *Metering Form 1 - Measuring Device Information* and metering readings. Enclosed are metering forms for this purpose.

YOUR RIGHT TO APPEAL

You have a right to appeal this decision to the Pollution Control Hearing Board (PCHB) within 30 days of the date of receipt of this decision. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal you must do the following within 30 days of the date of receipt of this decision:

- File your appeal and a copy of this decision with the PCHB (see addresses below). Filing means actual receipt by the PCHB during regular business hours.
- Serve a copy of your appeal and this decision on Ecology in paper form - by mail or in person. (See addresses below.) E-mail is not accepted.

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.




