Re: Water Right Permit No. G2-26830 for Paradise Estates Water System

Dear Sir or Madam:

In response to your request, you are hereby granted an extension to put the water to full beneficial use for the reason below:

- Consistent progress and due diligence is demonstrated in development of this permit. The water system is currently serving 198 residential connections and a community park. Significant system upgrades were made since the last extension was granted, including replacement of a leaky distribution system.
- Additional time is needed for full build-out based on forecasted local development and current economic conditions.

The new deadline to submit your *Proof of Appropriation of Water* is **November 1, 2016**.

YOUR RIGHT TO APPEAL

You have a right to appeal this decision to the Pollution Control Hearing Board (PCHB) within 30 days of the date of receipt of this decision. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal you must do the following within 30 days of the date of receipt of this decision:

- File your appeal and a copy of this decision with the PCHB (see addresses below). Filing means actual receipt by the PCHB during regular business hours.
- Serve a copy of your appeal and this decision on Ecology in paper form - by mail or in person. (See addresses below.) E-mail is not accepted.

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.
