Dear Mrs. Morefield:

In response to your request, you are hereby granted an extension to begin construction for the reason below:

- Septic system/drainfield issues delayed development. Property must be re-evaluated prior to beginning construction.

The new deadline to submit your *Construction Notice* is **October 1, 2013**.

You have a right to appeal this decision. To appeal this you must:

- File your appeal with the Pollution Control Hearings Board within 30 days of the “**date of receipt**” of this document. Filing means actual receipt by the Board during regular office hours.
- Serve your appeal on the Department of Ecology within 30 days of the “**date of receipt**” of this document. Service may be accomplished by any of the procedures identified in WAC 371-08-305(10). “Date of receipt” is defined at RCW 43.21B.001(2).

Be sure to do the following:

- Include a copy of this document that you are appealing with your *Notice of Appeal*.
- Serve and file your appeal in paper form; electronic copies are not accepted.


