Dear Mr. Jones:

In response to your request, you are hereby granted an extension to file a *Proof of Appropriation* on the above-referenced water rights for the reasons below:

- Desire to delay issuance of water right certificates due to ongoing litigation of the Municipal Water Law.
- Permits must remain in good standing while the System determines if change applications will be submitted.
- Good faith and due diligence has been demonstrated by working with Ecology to come up with a management plan of the above referenced rights, and through continual growth towards perfection of the rights.

The new deadline to put the water to **full beneficial use** and send completed Proof of Appropriation forms is **September 1, 2011**.

You have a right to appeal this decision. To appeal this you must:

- File your appeal with the Pollution Control Hearings Board within 30 days of the “date of receipt” of this document. Filing means actual receipt by the Board during regular office hours.
- Serve your appeal on the Department of Ecology within 30 days of the “date of receipt” of this document. Service may be accomplished by any of the procedures identified in WAC 371-08-305(10). “Date of receipt” is defined at RCW 43.21B.001(2).

Be sure to do the following:

- Include a copy of this document that you are appealing with your *Notice of Appeal*.
- Serve and file your appeal in paper form; electronic copies are not accepted.


