Dear Mr. Peterson:

In response to your request, you are hereby granted an extension to complete construction for the reason(s) below:

According to your request, all major construction has been completed. You have indicated that additional time will be required to repair the meter and finish other small details of the project. It appears you have made substantial goals in completing your project and putting water to use. Your requested extension is a reasonably short time. We will grant you an additional two years to complete your project.

The new deadline to submit your *Construction Notice* is **May 1, 2013**.

YOUR RIGHT TO APPEAL

You have a right to appeal this action to the Pollution Control Hearing Board (PCHB) within 30 days of the date of receipt of this document. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal, you must do the following within 30 days of the date of receipt of this document:

- File your appeal and a copy of this document with the PCHB (see addresses below). Filing means actual receipt by the PCHB during regular business hours.
- Serve a copy of your appeal and this document on Ecology in paper form - by mail or in person. (See addresses below.) Email is not accepted.



You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.


