Dear Mr. DeVries:

In response to your request, you are hereby granted an extension to put the water to full beneficial use for the reason(s) below:

- Another season is needed to maximize flow rate.
- More time is needed for the potential drilling of an additional well.

The new deadline to submit your *Proof of Appropriation of Water* forms is **October 31, 2010**. Please be reminded that under the Provisional terms of the change authorizations, "Water use data from each source shall be read and recorded weekly. The maximum monthly rate of withdrawal and the total monthly volume pumped shall be submitted to Ecology by January 31st of the following year." To date, the Department of Ecology (Ecology) has received no reports.

You have a right to appeal this decision. To appeal this you must:

- File your appeal with the Pollution Control Hearings Board within 30 days of the "date of receipt" of this document. Filing means actual receipt by the Board during regular office hours.
- Serve your appeal on the Department of Ecology within 30 days of the "date of receipt" of this document. Service may be accomplished by any of the procedures identified in WAC 371-08-305(10). "Date of receipt" is defined at RCW 43.21B.001(2).

Be sure to do the following:

- Include a copy of this document that you are appealing with your *Notice of Appeal*.
- Serve and file your appeal in paper form; electronic copies are not accepted.


