Re: Water Right Change No. **CG2-27594** (Driftwood Point)

Dear Mr. McAlister:

In response to your request, you are hereby granted an extension to file a *Proof of Appropriation* on the above-referenced water right for the reasons below:

- Current water system demand requires permit to remain in good standing.
- Rate of growth occurring at Driftwood Point is slower than expected due to local economic conditions.

The new deadline to put the water to **full beneficial use** and send a completed Proof of Appropriation form is **November 1, 2012**.

You have a right to appeal this decision. To appeal this you must:

- File your appeal with the Pollution Control Hearings Board within 30 days of the “date of receipt” of this document. Filing means actual receipt by the Board during regular office hours.
- Serve your appeal on the Department of Ecology within 30 days of the “date of receipt” of this document. Service may be accomplished by any of the procedures identified in WAC 371-08-305(10). “Date of receipt” is defined at RCW 43.21B.001(2).

Be sure to do the following:

- Include a copy of this document that you are appealing with your *Notice of Appeal*.
- Serve and file your appeal in paper form; electronic copies are not accepted.
