Dear Ms. Leffert:

In response to your request, you are hereby granted an extension to put the water to full beneficial use for the reason(s) below:

- The permittee has demonstrated good faith and due diligence in developing the water right; however, more time is needed to report and record measuring device information and water use data before submitting a *Proof of Appropriation of Water*.

The new deadline to submit your *Proof of Appropriation of Water* is **October 15, 2012**.

YOUR RIGHT TO APPEAL

You have a right to appeal this decision to the Pollution Control Hearing Board (PCHB) within 30 days of the date of receipt of this decision. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal you must do the following within 30 days of the date of receipt of this decision:

- File your appeal and a copy of this decision with the PCHB (see addresses below). Filing means actual receipt by the PCHB during regular business hours.
- Serve a copy of your appeal and this decision on Ecology in paper form - by mail or in person. (See addresses below.) E-mail is not accepted.

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.
