Dear Mr. Henne:

In response to your request of April 4, 2011, you are hereby granted an extension to complete construction for the reason(s) below:

Information provided in the City of Union Gap's (City's) December 2010 Water System Plan provide details of the steps taken to date to comply with the reference temporary authorizations, this includes, but may not be limited to:

- Adopting ordinances requiring the decommissioning of wells and transfer of associated exempt uses;
- The decommissioning of 28 wells during the implementation of Phase 3 improvement project being part of the Valley Mall Boulevard project;
- Extending city water services to the 28 well users;
- The receipt of funds to implement another phase of well decommissioning and the extension of city services to those well users.

The new deadline to submit your *Construction Notice* is **April 1, 2016**.

#### **YOUR RIGHT TO APPEAL**

You have a right to appeal this decision to the Pollution Control Hearing Board (PCHB) within 30 days of the date of receipt of this decision. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal you must do the following within 30 days of the date of receipt of this decision:

- File your appeal and a copy of this decision with the PCHB (see addresses below). Filing means actual receipt by the PCHB during regular business hours.
- Serve a copy of your appeal and this decision on Ecology in paper form - by mail or in person. (See addresses below.) E-mail is not accepted.

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.
