Dear Mr. Dawson:

In response to your request, you are hereby granted an extension to begin construction for the reason(s) below:

According to your request, you have obtained a building permit for a house. You plan to take up full time residence when the house is completed in late 2013 or the summer of 2014. The irrigation system is proposed to be constructed soon after. Your request is for a reasonable and short period of time. We will grant you an additional three years to begin your project.

The new deadline to submit your *Construction Notice* is May 1, 2014.

Department of Ecology personnel, upon presentation of proper credentials, shall have access at reasonable times, to the project location, and to inspect at reasonable times, records of water use, wells, diversions, measuring devices and associated distribution systems for compliance with water law.

### **YOUR RIGHT TO APPEAL**

You have a right to appeal this action to the Pollution Control Hearing Board (PCHB) within 30 days of the date of receipt of this document. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal, you must do the following within 30 days of the date of receipt of this document:

- File your appeal and a copy of this document with the PCHB (see addresses below). Filing means actual receipt by the PCHB during regular business hours.
- Serve a copy of your appeal and this document on Ecology in paper form - by mail or in person. (See addresses below.) Email is not accepted.



You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.
