Dear Ms. Martin:

In response to your request, you are hereby granted an extension to complete construction on the above-referenced water right for the reasons below:

- Failure of First Union Financial to pay for property transfer has resulted in a foreclosure and property has reverted back to Pine Tree Holdings.
- This has delayed the project and additional time is needed to sell the property and complete the project.

Your new deadline to complete construction and send a Completion of Construction form is **October 1, 2013.**

Please note this water right was assigned from Pine Tree Holdings to First Union Financial on May 1, 2008. In order to assure all correspondence is sent to the correct contact and simplify matters for a future sale, please submit an *Assignment of Application or Permit* form to update water right permit owner information. A copy of this form has been enclosed with this letter.

#### **YOUR RIGHT TO APPEAL**

You have a right to appeal this decision to the Pollution Control Hearing Board (PCHB) within 30 days of the date of receipt of this letter. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal you must do the following within 30 days of the date of receipt of this decision:

- File your appeal and a copy of this letter with the PCHB (see addresses below). Filing means actual receipt by the PCHB during regular business hours.
- Serve a copy of your appeal and this letter on Ecology in paper form - by mail or in person. (See addresses below.) E-mail is not accepted.

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.
