Dear Mr. Robischon:

In response to your request, you are hereby granted an extension to put the water to full beneficial use for the reasons below:

- Due diligence is shown in development of this project. All sources and distribution facilities for the Sunwood Lakes system are complete and in place. The system is currently serving 360 connections and is approved to serve 438.
- Delays were encountered due to recent economic conditions and the magnitude of this project for municipal supply purposes. Additional time is needed to allow full development of the Sunwood Lakes community.

The new deadline to submit your *Proof of Appropriation of Water* is **June 1, 2019**.

YOUR RIGHT TO APPEAL

You have a right to appeal this decision to the Pollution Control Hearing Board (PCHB) within 30 days of the date of receipt of this decision. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal you must do the following within 30 days of the date of receipt of this decision:

- File your appeal and a copy of this decision with the PCHB (see addresses below). Filing means actual receipt by the PCHB during regular business hours.
- Serve a copy of your appeal and this decision on Ecology in paper form - by mail or in person. (See addresses below.) E-mail is not accepted.

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.
