Dear Mr. Newman:

In response to your request, you are hereby granted an extension to put the water to full beneficial use for the reason below:

- Delay due to damaged metering equipment. A new fish screen has been installed to help solve the problem of debris from the river getting into the meter.

The new deadline to submit your *Proof of Appropriation* is **October 31, 2009**.

Please be reminded that Water Right Change Application No. CS4-CTCL1224 authorizes irrigation of three acres.

You have a right to appeal this decision. To appeal this you must:

- File your appeal with the Pollution Control Hearings Board within 30 days of the “date of receipt” of this document. Filing means actual receipt by the Board during regular office hours.
- Serve your appeal on the Department of Ecology within 30 days of the “date of receipt” of this document. Service may be accomplished by any of the procedures identified in WAC 371-08-305(10). “Date of receipt” is defined at RCW 43.21B.001(2).

Be sure to do the following:

- Include a copy of this document that you are appealing with your *Notice of Appeal*.
- Serve and file your appeal in paper form; electronic copies are not accepted.


