Dear Mrs. Buob, et al:

In response to your request, you are hereby granted an extension to begin construction for the reason(s) below:

- **Settle the estate issues.**

The new deadline to submit your *Construction Notice* is November 1, 2011.

The conditions of the extension letter dated April 7, 2009 (enclosed) are still required as part of this extension authorization. The dates are considered extended for one year.

You have a right to appeal this decision. To appeal this you must:

- File your appeal with the Pollution Control Hearings Board within 30 days of the “date of receipt” of this document. Filing means actual receipt by the Board during regular office hours.
- Serve your appeal on the Department of Ecology within 30 days of the “date of receipt” of this document. Service may be accomplished by any of the procedures identified in WAC 371-08-305(10). “Date of receipt” is defined at RCW 43.21B.001(2).

Be sure to do the following:

- Include a copy of this document that you are appealing with your *Notice of Appeal*.
- Serve and file your appeal in paper form; electronic copies are not accepted.


