Dear Mr. Pariseau:

In response to your request, you are hereby granted an extension to complete construction for the reason(s) below:

- Additional time is needed for the planting of remaining acreage and the installation of another pump with required metering devices.

The original permit was issued in 1995 with a Superseding Permit issued in 2004 with little or no progress since 2005; therefore, the new deadline to submit your *Construction Notice* is **May 1, 2010** and the new deadline to submit your *Proof of Appropriation* form is **May 1, 2012**.

You will need to diligently pursue the project during the additional time you are being given or further extensions may not be allowed. Provisions of the Permit (including metering) must also be completed.

You have a right to appeal this decision. To appeal this you must:

- File your appeal with the Pollution Control Hearings Board within 30 days of the “date of receipt” of this document. Filing means actual receipt by the Board during regular office hours.
- Serve your appeal on the Department of Ecology within 30 days of the “date of receipt” of this document. Service may be accomplished by any of the procedures identified in WAC 371-08-305(10). “Date of receipt” is defined at RCW 43.21B.001(2).

Be sure to do the following:

- Include a copy of the document that you are appealing.
- Serve and file your appeal in paper form; electronic copies are not accepted.


