Dear Mr. Brown:

In response to your request, you are hereby granted an extension to complete construction for the reason(s) below:

- Complete Wells 2 and 3 and bring the well online;
- Continue expansion and development of the permitted lands into beneficial use.

The new deadline to submit your *Construction Notice* is **April 1, 2014**.

Some of these lands are proposed for service from the Columbia Basin Irrigation District. Should water become available from facilities of any legally formed irrigation district or federal water is used on any or all of the lands described herein as the place of use, the quantities of water withdrawn under this authorization shall be proportionately reduced to correspond to the acreage for which district water is not available.

YOUR RIGHT TO APPEAL

You have a right to appeal this action to the Pollution Control Hearing Board (PCHB) within 30 days of the date of receipt of this document. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal, you must do the following within 30 days of the date of receipt of this document:

- File your appeal and a copy of this document with the PCHB (see addresses below). Filing means actual receipt by the PCHB during regular business hours.
- Serve a copy of your appeal and this document on Ecology in paper form - by mail or in person. (See addresses below.) Email is not accepted.



You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.
