On March 26, 2009, this office received a request from you to extend the complete construction deadline on Permit No. G4-23888P. We apologize for not responding sooner. We were processing an assignment request on said Permit at the time you submitted your request, which postponed an immediate response from us.

In response to your request, you are hereby granted an extension to complete construction for the reason(s) below:

- To address the numerous issues relating to contracts, insufficient nursery stocks, and the casing problem related to your well.

The new deadline to submit your Completion of Construction form is **January 1, 2012**.



The Superseding Permit acknowledging the recent assignments will issue with this new development schedule. The permit development schedule marries up with the development schedule associated with the Change Authorization (CG4-23888@1) on the Permit, which will accommodate your need for additional time to address the issues.

You have a right to appeal this decision. To appeal this you must:

- File your appeal with the Pollution Control Hearings Board within 30 days of the “date of receipt” of this document. Filing means actual receipt by the Board during regular office hours.
- Serve your appeal on the Department of Ecology within 30 days of the “date of receipt” of this document. Service may be accomplished by any of the procedures identified in WAC 371-08-305(10). “Date of receipt” is defined at RCW 43.21B.001(2).

Be sure to do the following:

- Include a copy of the document that you are appealing.
- Serve and file your appeal in paper form; electronic copies are not accepted.


