Dear Mr. Stiemert:

In response to your request, you are hereby granted an extension to complete construction for the reason(s) below:

According to your request, you will require additional time to complete your project due to the economic downturn and how it has affected your construction business sale. In addition, you have health problems that have hindered completion of the project. It appears you have made some goals in completing your project. Your request is for a reasonable and short period of time. We will grant you an additional three years to complete your project.

The new deadline to submit your *Construction Notice* is **October 1, 2015**.

#### **YOUR RIGHT TO APPEAL**

You have a right to appeal this action to the Pollution Control Hearing Board (PCHB) within 30 days of the date of receipt of this document. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal, you must do the following within 30 days of the date of receipt of this document:

- File your appeal and a copy of this document with the PCHB (see addresses below). Filing means actual receipt by the PCHB during regular business hours.
- Serve a copy of your appeal and this document on Ecology in paper form - by mail or in person. (See addresses below.) Email is not accepted.
