Dear Mr. Schwab:

On December 17, 2015, Department of Ecology (Ecology) received your request for an extension for the Beginning of Construction stage. In response to your request, the development schedule for the above referenced water right has been extended as follows:

Begin Construction: December 31, 2016

Basis of extension approval:

- The permit holder requires more time due to unexpected challenges drilling the well, including cost, terrain, and weather.

A one-year extension is reasonable given that the Permit was issued on February 10, 2014, providing the permitted two full seasons to drill the well.

YOUR RIGHT TO APPEAL

You have a right to appeal this Decision to the Pollution Control Hearings Board (PCHB) within 30 days of the date of receipt of this Decision. The appeal process is governed by chapter 43.21B RCW and chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal you must do all of the following within 30 days of the date of receipt of this Decision:

- File your appeal and a copy of this Decision with the PCHB (see addresses below). Filing means actual receipt by the PCHB during regular business hours.



- Serve a copy of your appeal and this Decision on Ecology in paper form – by mail or in person. (See addresses below.) E-mail is not accepted.

You must also comply with other applicable requirements in chapter 43.21B RCW and chapter 371-08 WAC.
