In response to your request, you are hereby granted an extension to complete construction for the reason(s) below:

According to your request you were unaware that you were required to install a flow meter and will need additional time to comply. It appears you have made goals in completing construction of your project and are pursuing it with diligence. Your request is for a reasonable period of time. We will grant you an additional year to complete your project.

The new deadline to submit your *Construction Notice* is **October 1, 2013**.

YOUR RIGHT TO APPEAL

You have a right to appeal this action to the Pollution Control Hearing Board (PCHB) within 30 days of the date of receipt of this document. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal, you must do the following within 30 days of the date of receipt of this document:

- File your appeal and a copy of this document with the PCHB (see addresses below). Filing means actual receipt by the PCHB during regular business hours.
- Serve a copy of your appeal and this document on Ecology in paper form - by mail or in person. (See addresses below.) Email is not accepted.
