Dear Mr. Scofield:

In response to your request, you are hereby granted an extension to **Complete Construction** for the reason(s) below:

- Developing a stable, viable crop takes time.
- Lag time between order and delivery of trees is not within your personal control.

You are currently in the Completion of Construction stage of the project. Construction is considered complete when all mainlines and sprinklers are in place and made ready for use, pumps and meter are installed, and the ability to actually deliver water to the complete project is operational. When the project is 100% complete, the filing of the **Completion of Construction** form is appropriate. Upon complete beneficial use of the water (irrigating crops) in agreement with the terms of the Permit, or for any lesser amount, a **Proof of Appropriation** form is appropriate.

The new deadline to submit your *Construction Notice* is **February 1, 2012**.

You have a right to appeal this decision. To appeal this you must:

- File your appeal with the Pollution Control Hearings Board within 30 days of the “date of receipt” of this document. Filing means actual receipt by the Board during regular office hours.
- Serve your appeal on the Department of Ecology within 30 days of the “date of receipt” of this document. Service may be accomplished by any of the procedures identified in WAC 371-08-305(10). “Date of receipt” is defined at RCW 43.21B.001(2).

Be sure to do the following:

- Include a copy of the document that you are appealing.
- Serve and file your appeal in paper form; electronic copies are not accepted.


