<p>The Primary Reach begins at the historical diversion point on the Yakima River located 300 feet north and 1200 feet east of the center of Section 29, (SE$\frac{1}{4}$SW$\frac{1}{4}$NE$\frac{1}{4}$) T. 18 N., R. 18 E.W.M. and ends at a point on the Yakima River approximately located within the NE$\frac{1}{4}$SW$\frac{1}{4}$ of Section 3, T. 17 N., R. 18 E.W.M.</p> <p>The Secondary Reach begins at a point on the Yakima River approximately located within the NE$\frac{1}{4}$SW$\frac{1}{4}$ of Section 3, T. 17 N., R. 18 E.W.M. and ends at the confluence of the Yakima and Columbia rivers in Wallula Lake located within the NW$\frac{1}{4}$SW$\frac{1}{4}$ of Section 19, T. 9 N., R. 29 E.W.M.</p>	<p>This temporary trust water right will be used for instream flow in Yakima River and for mitigation of hydraulic and consumptive use impacts and impacts to Total Water Supply Available in the Yakima River.</p>	
IRRIGATION METHOD:		
The entire acreage historically irrigated under Court Claim No. 00626 will be fallowed to create this trust water right.		
CONSUMPTIVE USE CALCULATION:		
The applicant estimated approximately 105.7 acre-feet as consumptive use for 38.81 acres historically irrigated under Court Claim No. 00626. (The remaining 1.19 acres have not been recently irrigated.)		
NARRATIVE DESCRIPTION OF PROJECT:		
Suncadia, LLC applied to transfer Court Claim No. 00626 to the Trust Water Right Program for the benefit of Yakima River instream flow augmentation. The trust water right is to be used for mitigation against the Suncadia's consumptive use impacts and impacts to Total Water Supply Available in the Yakima River.
