NARRATIVE DESCRIPTION OF PROJECT: <p>The authorized point of diversion is within the SE¼NW¼NE¼ of Section 35, T. 20 N., R. 15 E.W.M.</p> <p>The applicant proposes to change the point of diversion of 0.05 cfs, 10 acre-feet per year to a shallow groundwater well in hydraulic continuity with the Yakima River at a point located in the NW¼NW¼ of Section 35, T. 20 N., R. 15 E.W.M. to be used for domestic supply and irrigation from April 20 to September 30 on property described as that portion of the N½ of Section 35, T. 20 N., R. 15 E.W.M. lying Northerly and Easterly of the Yakima River; together with all right, title and interest in that permanent easement, from the City of Cle Elum, 66 feet in width, over and across the NE¼NE¼ of Section 35, T. 20 N. R. 15 E.W.M., dated February 8, 1988 and recorded February 18, 1988 in the records of Kittitas County, WA under Auditor's File No. 510774; Excepting the NE¼NE¼ of said Section 35; and also Excepting that portion, thereof, conveyed to the State of Washington for highway purposes by deed dated June 25, 1965, recorded September 10, 1965 under Auditor's file No. 323992 and by deed dated September 16, 1965, recorded December 29, 1965 under Auditor's File No. 326601.</p>
