 The applicant proposes to essentially combine two different water rights, Court Claim Nos. 01525 & 01527, by changing the point of diversion to Court Claim No. 01527 to a downstream location on Carrier Creek and adding the point of diversion authorized in Court Claim No. 01525. The applicant also proposes to change the place of use to Court Claim No. 01525. Both Court Claims (01525 & 01527), if authorized, will share two points of diversions and place of use for the irrigation of a combined 20 acres.
