1 THE GRANTORS, GAYLE MARGARET REICHEL, a single person, LINDA
2 MAE REICHEL, a single person, KENNETH MELVIN REICHEL and LILLIAN
3 REICHEL, his wife, for and in consideration of ten dollars (\$10.00)
4 and other good and valuable considerations whereof is hereby ack-
5 nnowledged, conveys and quit claims to BEULAH REICHEL, a widow, the
6 following described real estate, situated in the county of Thurston,
7 State of Washington, together with all after acquired title of the
8 grantors therein:

9 The South half of the northeast quarter (S $\frac{1}{2}$ NE $\frac{1}{4}$), and the east
10 half of the northwest quarter (E $\frac{1}{2}$ NW $\frac{1}{4}$) of section thirty-four (34),
11 Township sixteen (16) North, Range two (2) East of the Willamette
12 Meridian;

13 EXCEPTING therefrom, eighteen (18) acres conveyed to the Weyer-
14 haeuser Timber Company by deed dated August 16, 1900 and recorded
15 in volume 62 of Deeds, at page 545; also

16 EXCEPTING therefrom, beginning on the east line of said section
17 thirty four (34), Township sixteen (16) North, Range Two (2) East
18 of the Willamette Meridian, at a point 2275 feet south of the
19 northeast corner of said section; thence parallel with the north
20 line of the northeast quarter of said section, West 1070 feet, more
21 or less, to the center of the Deschutes River; thence upstream
22 along the center of said river, southeasterly to the south line of
23 said northeast quarter of section thirty-four (34); thence on the
24 said south line east to the southeast corner of said northeast
25 quarter; thence on the east line of said Subdivision north 365 feet
26 more or less to the place of beginning, also

27 EXCEPTING therefrom, that part of the northeast quarter of the north-
28 west quarter (NE $\frac{1}{4}$ NW $\frac{1}{4}$) of section 34, Township sixteen (16) North,
29 Range Two (2) East of the Willamette Meridian, beginning at the
30 southwest corner of said northeast quarter of the northwest quarter
31 of said section 34, running thence due north twenty rods, thence
32 due east 48 rods, thence north to the county road, thence following
the south or West line of said county road to the Deschutes river;
thence following along the north bank of the Deschutes River; thence
following along the north bank of the Deschutes River to its inter-
section with the north and south line between the east half and
west half of the northwest quarter of said section; thence north
along said line to the point of beginning, containing 18 $\frac{1}{2}$ acres
more or less.

EXCEPTING therefrom, a tract of land situated in the Southeast
Quarter of the Northeast Quarter of Section 34, Township 16 North,
Range 2 East W. M. and described as follows: Beginning at a point
on the East line of Section 34 1346.68 feet South 2^o46' West from
the Northeast corner; thence South 2^o46' West along said East line
of Section 34 928.36 feet; thence North 89^o47' West 970 feet more
or less to the center of the Deschutes River; thence Northwesterly
along the center line of said river to the intersection of the South
line of the North one-half of the Northeast Quarter; thence South
89^o39' East along said South line 1400 feet more or less to the
Place of Beginning containing approximately 24 acres.

EXCEPTING therefrom, a tract of land situated in the Southeast Quar-
ter of the Northwest Quarter of Section 34 Township 16 North, Range
2 East W. M. and described as follows: Beginning at the Southwest
corner of the southeast Quarter of the Northwest quarter; thence
South 89^o47' East along the South Line of said subdivision 485.0
feet; thence North 2^o15' East parallel with the West line of said
subdivision 980 feet more or less to the North bank of the Deschutes
River; thence Southwesterly along said North bank to the West line
of the Southeast Quarter Northwest Quarter; thence South 2^o15' West
along said West line 840 feet more or less to the Place of Beginning
containing approximately 10 acres.
