That by virtue of a decree of the Superior Court of the State of Washington in and for Chelan County, made and entered on the fourteenth day of June, 1928, and recorded in Volume 14 of the Superior Court Journal of said County at page 107, from which decree no appeal was taken, and which decree determined the rights of all known claimants to the use of the waters of Squillchuok Creek a tributary of the Columbia River

WENATCHEE, WASHINGTON

is entitled to use, subject to the laws of the State of Washington, the waters of said Squillchuok Creek for the purpose of irrigation during the ~~XXXXXX~~ irrigation season to each year.

That the amount of water to which said water right is entitled is limited to the quantity which is reasonably and actually necessary for the purpose aforesaid and shall not exceed 0.05 second feet for the irrigation of acres of the lands hereinafter described.

That the date of priority of said water right is 1870; that the decree aforesaid establishes said right in Class One, which said class includes a total maximum of 8.815 second feet; that the possible maximum amount of water which is comprehended in rights prior to this right is second feet.

That the point of diversion of said water right is as follows:
The NE 1/4 of the NE 1/4, Sec. 8, Twp. 21 N., Rge 20 E. W. M.

and cannot be changed except as provided in Section 39, Chapter 117, Session Laws of 1917.

That said water right was adjudged by said decree to be and is appurtenant to the following described real property situated in Chelan County, Washington, to wit: Part of the SW 1/4 of the SW 1/4 and part of the SE 1/4 of the SW 1/4 of Sec. 4, Twp. 21 N., Rge 20 E. W. M.

Note: When the water supply of Squillchuok Creek is insufficient to fill the whole of the Philip Miller right of 400 miner's inches under 4-inch pressure, each water user owning a part of such right shall bear his proportionate share of the quantity deficient, excepting the right of Mr. F. Meier for 20 miner's inches under 4-inch pressure; the Loma Land Company for 5 miner's inches under 4-inch pressure; and James H. Barcroft for 2 miner's inches under 6-inch pressure, which shall not be subject to such reduction.
