**CERTIFICATE OF CHANGE VOL 1-4, PAGE 309, TO CHANGE THE POINT OF
DIVERSION UNDER WENAS CREEK ADJUDICATED CERTIFICATE NO. 60.**

IN accordance with the provisions of Chapter 90.03 and 90.44 of the Revised Code of Washington (RCW) and the regulations of the Department of Ecology:

This is to certify that Ronald & Marcia Dixon of Selah, Washington are hereby granted the right to:

Change the point of diversion under Wenas Creek Adjudicated Certificate No. 60. Said certificate was confirmed in the 1921 adjudication of surface water of Wenas Creek, and again recommended for confirmation in the ongoing Yakima River Basin Adjudication. That portion of said authorization for Ronald & Marcia Dixon confirms a use of 0.29 cubic feet per second, 58 acre-feet per year for irrigation of 14.5 acres. (Parcel No. 181410 23410)

The authorized point of diversion was located in NE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 9, T. 14 N., R. 18 E.W.M., Yakima County.

This Certificate of Change authorizes the Dixon's change of point of diversion of the confirmed quantity of water to the location described below:

The point of diversion being located 1000 feet north and 570 feet east from the west quarter corner of Section 10, being within the SW $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 10, T. 14 N., R. 18 E.W.M., Yakima County. (Parcel No. 181410 23410)

All provisions of the right remain as required and confirmed in the Second Supplemental Report of Referee, Subbasin 15, Re: Subbasin 15, and subject to the recommendations of the Conditional Final Order, Subbasin 15.

Final issuance of an Adjudicated Certificate of Water Right in the Yakima River Basin Adjudication should reflect this change in point of diversion. Upon issuance of the final decree and adjudicated certificates, it is expected that the court will make all previous state issued surface water documents null and void.
