The appropriate Regional Office will be happy to answer any further questions you may have.

There have been no changes to the existing irrigation system because of the addition of these proposed acres. The facilities for water delivery are the same that were described on Surface Water Certificates No. S4-24123c(A), S4-24123c(B), S4-24123c(C), S4-24123c(D), S4-24123c(E) and S4-24123c(F). These facilities were completed during the spring of 1977 and consists of six 2000 HP pumps at the river station located one half mile southwest of Paterson. Water is pumped through a 54 inch mainline to a system of booster pumps that delivers water to the proposed place of use.







I have enclosed the Surface Water Applications which you returned to us for further information. I have given specific written driving instructions on the space provided in the application and, as an explanation of the circles on the topographical maps, I propose the following statements:

Brent Hartley and Jim Moon Application

There is to be a center pivot irrigation machine covering 130 acres installed in the solid circle marked 1st year (SE 1/4 of Sec. 12) then it is to be moved each succeeding year to another circle (broken circles) until the four circles have been farmed. There will be only one machine irrigating 130 acres in any given year.

Brent Schulthies and Shirl Moon Ranch, Inc. Application

There is to be a center pivot irrigation machine covering 127 acres installed in the solid circle marked 1st year (NE 1/4 of Sec. 19). The second year it will be moved to the broken circle and in the fifth year it will be moved to the broken half-circle. There will be only one machine irrigating a maximum of 127 acres in any given year.

Duane Munn and Connie Potter Application

There is to be one center pivot irrigation machine located in this 1/4 section irrigating 124 acres.

Clyde Bybee and Loretta Gugin Application

This section of ground will contain two center pivot irrigation machines each irrigating 130 acres, which will be rotated throughout the section. The machines will be located in the solid circles marked 1 and 4 the first year (SW 1/2 and NE 1/4 of Sec. 10). The second year #1 will be moved to #2, the third year #4 will be moved to #5, the fourth year #2 will be moved to #3, and the fifth year #5 will be moved to #6. There will be only two machines irrigating a total of 260 acres in any given year.
