A description of the lands to which such ground water right is appurtenant: Port of Kennewick Property: That portion of the NE 1/4 of Sec. 23, and of the SW 1/4 SE 1/4 of Sec. 14, T. 8 N., R. 30 E.W.M., described as follows: Beginning at a point in the south line of the Government Lot 1 of said Sec. 23, 580 feet east of the southwest corner thereof; thence north 250 feet; thence in a northwesterly direction to a point in the north line of said Sec. 25, 40 feet east of the north quarter corner thereof; thence at right angle to last described line to a point on the line of the normal operating pool elevation of the McNary Reservoir; thence southeasterly and south along said elevation line to the intersection with the south line of said Government Lot 1; thence west along said south line to the point of beginning.




