



POINTS OF WITHDRAWAL

Well No. 1 (new):

250 feet south and 100 feet east of the northwest corner of Section 10, Township 29 N., Range 25 E., W.M. This withdrawal point is supplied by ground water that has infiltrated to pond in the bottom of a large gravel pit. A 50 hp pump with a metal intake has been installed to utilize this supply.

Well No. 2 (new):

500 feet south and 400 feet east of the northwest corner of Section 10, Township 29 N., Range 25 E., W.M. This well is located on the edge of the aforementioned gravel pit. It is a drilled well having a 14 inch casing. A submersible 20 hp pump is used to withdraw water from the well.

Well G3-20151C (existing):

980 feet north and 1060 feet east of the southwest corner of Section 3, Township 29 N., Range 25 E., W.M.

Well G4-23840C (existing):

180 feet south and 300 feet east of the northwest corner of Section 10, Township 29 N., Range 25 E., W.M.

Well G4-27108C (existing):

1100 feet south and 465 feet west from the north quarter corner of Section 10, Township 29 N., Range 25 E., W.M.



A parcel in the Southwest quarter of the Southeast quarter of Section 3, and the Northwest quarter of the Northeast quarter of Section 10, Township 29 North, Range 25 E.W.M. described as follows: Beginning at the south quarter corner of said Section 3; thence North to the northwest corner of the Southwest quarter of the Southeast quarter; thence East 662.2 feet, more or less, to the westerly right of way line of Chief Joseph Dam Access Road; thence South 13 degrees 47'30" West along said right of way line 1352.73 feet to road survey station No. 906+00; thence North 76 degrees 12'30" West 15 feet; thence South 13 degrees 47'30" West 600 feet; thence South 76 degrees 12'30" East 15 feet; thence South 13 degrees 47'30" West 785.7 feet, more or less, to the west line of the Northwest quarter of the Northeast quarter of Said Section 10, thence north to the point of beginning.

The South half of the Southwest quarter of Section 3; Lot 7, Section 4; and Lot 5 of Section 9, Township 29 North, Range 25, E.W.M. EXCEPT that portion conveyed to the Public Utility District No. 1 of Douglas County, Washington, by deed recorded in Book 196 of Deeds, file No. 532121. AND EXCEPT that part included in the right of way of State Highway 10A [SR-17] described as follows: Beginning at the southwest corner of said North half of the Northwest quarter of Section 10, thence West 8.6 feet; thence North 13 degrees 47'30" East 36.12 feet; thence South 35.07 feet to the point of beginning
