



Well is not yet drilled so size of pump cannot be determined, but whatever will be necessary with water available. We hope for approx. 300 space RV park. We plan a few full hook ups but mostly power only with water & dump station, bath house, showers and laundromat.




Scale: 1 inch = 800 feet (each small square = 10 acres)


