West ½ of Section 38, Township 3N, Range 8E in Skamania County.

North ½ of Section 37, Township 3N, Range 8E in Skamania County.

South ½ of Section 27, Township 3N, Range 8E in Skamania County.

Parcel Descriptions for water use

A tract of land located within Section 27, Township Three North, Range Eight East, of the Willamette Meridian, in the County of Skamania and the State of Washington and described as follows:

Parcel 1:

Beginning at the northwest corner of the William M. Murphy D.L.C. No. 37; running thence East, 447.03 feet; thence S 14° 15' W, 193.50 feet; thence N 82° 43' E, 107.0 feet; thence S 28° 31' W, 260.0 feet; thence S 19° 17' E, 471.0 feet; thence S 84° 28' W, 89.5 feet; thence N 24° W, 142.0 feet; thence N 14° W, 60.0 feet; thence N 23° W, 93.0 feet; thence N 28° W, 100.0 feet; thence N 44° W, 200.0 feet; thence N 47° W, 116.0 feet; thence N 43° W, 111.4 feet; thence West, 71.31 feet; thence N 22° E, 201.50 feet to the point of beginning;

Parcel 2:

Beginning at the northwest corner of the William M. Murphy D.L.C. No. 37; thence East along the North line of said Murphy D.L.C., 447.03 feet; thence S 14° 15' W, 193.5 feet; thence N 82° 43' E, 137. Feet to the centerline of Lyons Road; thence Northwesterly along the centerline of said Lyons Road, 168 feet to a point on the North line of said Murphy D.L.C., said point being 462.03 feet East of the northwest corner of said Murphy D.L.C.; thence East along said North line, 327 feet to the centerline of County Road No. 30360, known as Berge Road; thence along the centerline of Berge Road N18° E, 136.5 feet; thence N 20° 58' W, 216.9 feet; thence N 49° 15' E, 325.1 feet; thence S 84° 18' E, 165.4 feet; thence leaving said road centerline N 28° 07' E, 65 feet; thence West and parallel with the North line of said Murphy D.L.C., 920 feet to a point on the Government meander line on the East side of Wind River; thence Southerly along said Government meander line a distance of 620 feet to the Northwest corner of said Murphy D.L.C. and the point of beginning; EXCEPT Public Roads;




