6. DESCRIPTION OF SYSTEM PROPOSED OR INSTALLED

3 pumps (40 hp., 15 hp., 1 hp.) pumping into our irrigation network where the water is utilized throughout the farm's total acreage. This network is fed by numerous sources with numerous water rights.

REMARKS

7. We have worked extensively with the Department of Fisheries and have dug ponds to store up the water for when it is needed. We have also installed fish ladders within our pond system. The Dept. of Fisheries stocks the ponds with fingerling salmon.


Marvin Enfield is the legal owner of the following properties listed on Note "A" (the attached legal descriptions): A,B,C,D,E,F,G,H,and I.
