


LEGAL DESCRIPTION

Beginning at the Southwest corner of the Albert Briggs Donation Claim in Section 17, Township 30 North, Range 1 W.W.M.; thence North, along the West boundary line thereof 1562.88 feet to the true point of beginning of the tract herein described;
thence East 1207.41 feet to the West line of the East 10 acres of what was formerly known and described on the Assessor's Map and Description Book as Tax 7;
thence North, along said West line, to a point on a line drawn East from a point on the West line of said Donation Claim distant 2344.32 feet North of the said Southwest corner thereof;
thence West, along said line 324.99 feet, more or less, to a point thereon which is 882.42 feet East of said point;
thence North 1562.88 feet, more or less, to the North line of said Section 17;
thence West, along said North line, 882.42 feet to the Northwest corner of said Donation Claim; thence South, along the West line thereof, 2344.32 feet more or less, to the true point of beginning;
situate in the County of Jefferson, State of Washington.
